#### Minutes:

### Special Report-Washington Federal Save at School:

Justin Pond presents the Save at School program offered by Washington Federal to the board. Washington Federal will send the enrollment forms to the school to be given out to each student. Those forms will then be turned in to the office and the information will be sent to Washington Federal to open the account. A \$5.00 deposit is needed to open each account for each student. An employee from Washington Federal will return each month to take the children's deposits. A motion was made by Director Tappia Infanger and seconded by Secretary Sara Schofield to approve offering the Save at School program through Washington Federal at American Heritage. #### Tappia Infanger (playground equip, fundraising update, library progress)

- 1. Director Tappia Infanger reported that the Wendy's night was a great success earning the school just under \$500.00.
- 2. The Halloween Carnival was the largest fundraiser of the year bringing in an amazing \$4300.00. Many parents and students are commended for the amazing time and energy that was spent to make it such a huge success.
- 3. Grandparent's Day will be held on the 8<sup>th</sup> of October. Cinnamon Rolls and milk will be served for \$1.00 each. Pictures will also be offered for \$7.00.
- 4. Monday, a Veteran's Day assembly will be held for all students. Ceremonies will begin at 10:00 am. The middle school will then get to take part in the ceremony of retiring a flag in the rear of the school at the fireplace being led by military personnel.
- 5. The Barnes and Noble day will be taking place on November 14<sup>th</sup>, 2013. The advanced orchestra will be performing during the day and all purchases where AHCS is mentioned will earn the school 20% of in store credit for purchases at a later date.

- 6. The music storage closet was recently remodeled into a teacher work room due to a parent of the school offering his labor at no cost.
- 7. A portion of The Bill of Rights was put up this past weekend along the wall of the gym thanks to Tappia and Deby Infanger. The gym has now been named Freedom Hall and will eventually have all of the Bill of Rights displayed there.
- 8. The playground equipment has been ordered and should arrive the first week of December.
- 9. The mayoral debate went very well and the students that participated asked some amazing questions. It was a very positive experience.
- 10. A parent has volunteered to sponsor a debate team for AHCS. This will begin in January after the holidays.
- 11. The current balance in the PFA account is \$8,000.00.

### **Compass Academy Visit**
