- Lego Club will also begin. She will have each grade level from K-3 have their own time for this club. She will be starting with Kindergarten and working up through third grade.
- We held Parent-Teacher Conferences, and it was great to see all the parents come to the school. I
  appreciate all the parents who brought in dinner for the teachers. We love our parents here at
  American Heritage Charter School.
- I am attaching our Strategic Plan for the 2024 school year. The area we would like to focus on is ensuring we understand our essential standards and then making sure those essential standards are being taught within our curriculum.
