Administrative, PFA, and Student Reports and Recommendations

Elementary Update

Dr. Hust submitted the following for her update:

- We held our Accreditation Meeting before we left for Thanksgiving Break. Mr. Scott was our
 accreditation led. He was out of Utah but has worked in schools and charters in Nevada. The
 meeting went very well. He interviewed students, teachers, admin, and parents. Here are a
 few takeaways that he received from those interviews. Everyone is on the same page and no
 one had anything negative to say about our school
- 1. Students: They wish more tutoring were provided every day after school, even from peers
 Love their mentos but wish they were less clinical and more personable
 Would like to see more sports opportunities like soccer
 They knew about the discipline processes and there was no
 negative pushback on the cellphone policies
 They feel our school is an easy place to learn, they enjoy it, and they wouldn't
 want to be any place else.
- 2. Parents: The Admin is very approachable and they are treated with respect.

The curriculum could be more aggressive.

Too many points of entry and would like us to lock them down

They feel their students are on par or ahead of other students with academics

They feel people are treated fairly

They feel we are always looking for ways to make our school better by listening

3. Staff: Lots of hats people wear

Students with behavioral needs may not get what they can at other schools

If they need something, money is always there.

They appreciate taking their classes on trips.

They feel they have everything they need.

The teachers in 4th and 5th feel like they don't belong.

 continues to impress. They won their playoff game this past Tuesday, and we're looking
 forward to their next game tonight at 5 pm. To celebrate their success, we are hosting a
 special middle school-only celebration dance after the game, which will run until 8:30 pm.
 This will be a great way for the students to unwind and celebrate their hard work and team
 spirit.
- The students had a great time creating door decorations for the Pocatello Veterans Home. Tomorrow, Mr. Rose and I will be delivering the decorations along with donated gifts to the Veterans Home. This is our second year making the door decorations and I hope we can continue to serve them in this way for years to come.
- This morning, we also held a very successful all-house meeting, which featured some fun relays and competitions. These activities were designed to highlight last month's SWEAT Pledge verse of the month, fostering team spirit and reinforcing important character-building values.
